GEORGIA IRP STAGGERED REGISTRATION & RENEWAL PERIODS

January IRP renewals:

- Individuals or Sole Proprietors with last names beginning with the letters "A" & "B."
- Businesses, Corporations, or LLCs with first names beginning with the letters "A" & "B."
- Fleets (including IRP apportioned license plates & IRP Cab Cards) expire January 31st.
- Once fleet is renewed, new registrations begin February 1st (12 mos. Registration).
- **We request that January renewals are filed by November 15th.**
- Fleet renewals filed late are assessed a mandatory 10% late filing penalty.
- Fleet renewal invoices paid after January 31st are assessed a mandatory 25% late payment penalty.

February IRP renewals:

- Individuals or Sole Proprietors with last names beginning with the letters "C" & "D."
- Businesses, Corporations, or LLCs with first names beginning with the letters "C" & "D."
- Fleets (including IRP apportioned license plates & IRP Cab Cards) expire February 28th.
- Once fleet is renewed, new registrations begin March 1st (12 mos. Registration).
- **We request that February renewals are filed by December 15th.**
- Fleet renewals filed late are assessed a mandatory 10% late filing penalty.
- Fleet renewal invoices paid after February 28th are assessed a mandatory 25% late payment penalty.

March IRP renewals:

- Individuals or Sole Proprietors with last names beginning with the letters "E" & "F."
- Businesses, Corporations, or LLCs with first names beginning with the letters "E" & "F."
- Fleets (including IRP apportioned license plates & IRP Cab Cards) expire March 31st.
- Once fleet is renewed, new registration begins April 1st (12 mos. Registration).
- **We request that March renewals are filed by January 15th.**
- Fleet renewals filed late are assessed a mandatory 10% late filing penalty.
- Fleet renewal invoices paid after March 31st are assessed a mandatory 25% late payment penalty.

April IRP renewals:

- Individuals or Sole Proprietors with last names beginning with the letters “G” & “H.”
- Businesses, Corporations, or LLCs with first names beginning with the letters “G” & “H.”
- Fleets (including IRP apportioned license plates & IRP Cab Cards) expire April 30th.
- Once fleet is renewed, new registration begins May 1st (12 mos. Registration).
- **We request that April renewals are filed by February 15th.**
- Fleet renewals filed late are assessed a mandatory 10% late filing penalty.
- Fleet renewal invoices paid after April 30th are assessed a mandatory 25% late payment penalty.

May IRP renewals:

- Individuals or Sole Proprietors with last names beginning with the letters “I” & “J.”
- Businesses, Corporations, or LLCs with first names beginning with the letters “I” & “J.”
- Fleets (including IRP apportioned license plates & IRP Cab Cards) expire May 31st.
- Once fleet is renewed, new registration begins June 1st (12 mos. Registration).
- **We request that May renewals are filed by March 15th.**
- Fleet renewals filed late are assessed a mandatory 10% late filing penalty.
- Fleet renewal invoices paid after May 31st are assessed a mandatory 25% late payment penalty.

June IRP renewals:

- Individuals or Sole Proprietors with last names beginning with the letters “K” & “L.”
- Businesses, Corporations, or LLCs with first names beginning with the letters “K” & “L.”
- Fleets (including IRP apportioned license plates & IRP Cab Cards) expire June 30th.
- Once fleet is renewed, new registration begins July 1st (12 mos. Registration).
- **We request that June renewals are filed by April 15th.**
- Fleet renewals filed late are assessed a mandatory 10% late filing penalty.
- Fleet renewal invoices paid after June 30th are assessed a mandatory 25% late payment penalty.

July IRP renewals:

- Individuals or Sole Proprietors with last names beginning with the letters “M” & “N.”
- Businesses, Corporations, or LLCs with first names beginning with the letters “M” & “N.”
- Fleets (including IRP apportioned license plates & IRP Cab Cards) expire July 31st.
- Once fleet is renewed, new registration begins August 1st (12 mos. Registration).
- **We request that July renewals are filed by May 15th.**
- Fleet renewals filed late are assessed a mandatory 10% late filing penalty.
- Fleet renewal invoices paid after July 31st are assessed a mandatory 25% late payment penalty.

August IRP renewals:

- Individuals or Sole Proprietors with last names beginning with the letters “O” & “P.”
- Businesses, Corporations, or LLCs with first names beginning with the letters “O” & “P.”
- Fleets (including IRP apportioned license plates & IRP Cab Cards) expire August 31st.
- Once fleet is renewed, new registration begins September 1st (12 mos. Registration).
- **We request that August renewals are filed by June 15th.**
- Fleet renewals filed late are assessed a mandatory 10% late filing penalty.
- Fleet renewal invoices paid after August 31st are assessed a mandatory 25% late payment penalty.

September IRP renewals:

- Individuals or Sole Proprietors with last names beginning with the letters “Q” & “R.”
- Businesses, Corporations, or LLCs with first names beginning with the letters “Q” & “R.”
- Fleets (including IRP apportioned license plates & IRP Cab Cards) expire September 30th.
- Once fleet is renewed, new registration begins October 1st (12 mos. Registration).
- **We request that September renewals are filed by July 15th.**
- Fleet renewals filed late are assessed a mandatory 10% late filing penalty.
- Fleet renewal invoices paid after September 30th are assessed a mandatory 25% late payment penalty.

October IRP renewals:

- Individuals or Sole Proprietors with last names beginning with the letters “S” & “T.”
- Businesses, Corporations, or LLCs with first names beginning with the letters “S” & “T.”
- Fleets (including IRP apportioned license plates & IRP Cab Cards) expire October 31st.
- Once fleet is renewed, new registration begins November 1st (12 mos. Registration).
- **We request that October renewals are filed by August 15th.**
- Fleet renewals filed late are assessed a mandatory 10% late filing penalty.
- Fleet renewal invoices paid after October 31st are assessed a mandatory 25% late payment penalty.

November IRP renewals:

- Individuals or Sole Proprietors with last names beginning with the letters “U”, “V,” & “W.”
- Businesses, Corporations, or LLCs with first names beginning with the letters “U”, “V,” & “W.”
- Fleets (including IRP apportioned license plates & IRP Cab Cards) expire November 30th.
- Once fleet is renewed, new registration begins December 1st (12 mos. Registration).
- **We request that November renewals are filed by September 15th.**
- Fleet renewals filed late are assessed a mandatory 10% late filing penalty.
- Fleet renewal invoices paid after November 30th are assessed a mandatory 25% late payment penalty.

December IRP renewals:

- Individuals or Sole Proprietors with last names beginning with the letters “X”, “Y”, & “Z.”
- Businesses, Corporations, or LLCs with first names beginning with the letters “X”, “Y,” & “Z.”
- Fleets (including IRP apportioned license plates & IRP Cab Cards) expire December 31st.
- Once fleet is renewed, new registration begins January 1st (12 mos. Registration).
- **We request that December renewals are filed by October 15th.**
- Fleet renewals filed late are assessed a mandatory 10% late filing penalty.
- Fleet renewal invoices paid after December 31st are assessed a mandatory 25% late payment penalty.
